GTAP related activities of the USITC

The USITC continued to use GTAP products in a number of formal and informal studies during the past year. In addition the ITC has made suggestions to GTAP staff on methods for updating the US database, developed alternative approaches to calibrating and developing baselines for dynamic analysis, and generated econometric estimates of short and long term Armington substitution elasticities at the detailed commodity level for the United States. Over the coming year the ITC will be building a new, highly detailed dynamic U.S. model with updated parameters, state level components, and greater labor detail. We expect the new model's database and parameters to collapse to a GTAP consistent aggregation. The ITC will also be using GTAP as part of the U.S. government's interagency (including ERS and EPA) efforts to assess the environmental effects of free trade agreements.
