GTAP activities LEI, 2000

The Agricultural Economic Research Institute (LEI) has been a member of the GTAP consortium since November 1996. We use GTAP for a variety of research related to international trade in agri-food products. A summary of our activities over 2000:

Consortium related

- Finalization of EU DG VI and DG XI funded concerted action project: "Assessment of the GTAP modelling framework for policy analyses from a European perspective". This project had 10 European partners who (potentially) use GTAP. Besides LEI, there are 3 more consortium members involved (SJFI, FAL and Joe Francois). LEI has coordinatied this effort. We started February 1, 1999 and the project is officially finished January 2001. The project has resulted in a number of research papers, some of which have been presented at conferences and some have made it into the Journals. Two workshops have been held, one in Copenhagen and one in Rotterdam, which each attracted some 40 participants. The Copenhagen proceedings have been edited by SJFI (Soren Frandsen & Michael Staehr), and the Rotterdam proceedings are edited by LEI (Frank van Tongeren and Hans van Meijl). We are now planning to publish a book based on the results of the project: Preliminary title: Global Trade Analysis: European Policy Issues
- Construction of disaggregated IO tables for the EU15 for version 5 of the GTAP dataset.
 This is co-funded by EU DG XII (energy & environment) the Dutch Ministry of Agriculture
 and LEI. These tables are now used in GTAP version 5.3 (pre-release). We also
 delivered EU energy-IO tables to the funding agency. This tabel has been constructed
 using GTAP-E data.
- Hans van Meijl and Frank van Tongeren served as instructors on the 2000 GTAP short course. One LEI researcher (Frank Bunte) has attended the 2000 course, another one (Andrzej Tabeau) is planning to attend the 2001 edition. Frank van Tongeren has served on the conference organization board in 2000 and 2001.

Research involving GTAP in 2000

- WTO and developing countries: Policy research Dutch Ministry of Agriculture, focusing on North-South relations and food processing industries.
- China's food economy in the early 21st century (financed by Dutch Ministry of Agriculture). Partner: CCAP of Chinese Academy of Sciences (Jikun Huang). This project started in October 1999 and will continue until fall 2002. The project is preparing an 'Outlook' of the Chinese food economy until 2020 (another magic year). The GTAP contribution lies in providing an international trade dimension to the national projections. We are linking the CAPSIM model of CCAP to GTAP projections.
- Modelling the EU CAP. In the context of the GTAP-EU concerted action, we developed a number of extensions to the standard GTAP model, including the representation of intervention prices and production quota.
- EU enlargement: Policy Research Dutch Ministry of Finance and Ministry of Agriculture. Cost of EU enlargement under alternative WTO scenarios.
- Effects of further policy liberalisation on EU and Dutch agriculture. Dutch Ministry of Agriculture.
- WTO trade liberalisation and food security. Joint work wit the OECD secretariat (directorare food, agriculture and fisheries). Effects of OECD trade liberalisation onf food security in developing countries. The project employs OECD AGKLINK and GTAP as analytical tools.
- TRADEFLOW. This project seeks to develop new methods to visually present complex (trade) data and to help users in the analysis of data and simulation results. This work combines IT specialists, statisticians, GIS speacialists and modellers. It is funded from Wageningen UR and GTAP. First results will be presented at the board meeting.

New and upcoming research

Joint work with FAL Germany on modelling the EU CAP. (see board report by FAL)

- EU dairy policy reform. Policy research Dutch Ministry of Agriculture.
- WTO and Bangladesh. Joint work with IFPRI. Funded by Dutch Ministry of Foreign affairs and DIFID (UK).
- PROFETAS: A large multi-disciplinary project that studies the posssibilities of protein crops as substitute for animal proteins in the human diet. Our part in this project is to look into the internatinal trade implications. This project is funded by the Dutch Organisation for the advancement of Research (NWO).
